# EB-5 Investment Green Card Services and Fees

## EB-5 Investment Green Card Services and Fees [1]

The fee schedule for EB-5 Direct Investment (fees are payable by personal or corporate checks) is as follows:

1.	<p>Legal Fees (for our Office):</p> <p>\$10,000 payable as follows for preparing I-526 Immigrant Petition: \$5,000 at the commencement of the case and the rest in two monthly installments of \$2500, to be paid on the 1st day of each month following the month in which the case is opened by the Law Offices.</p> <p>For preparing I-485 Adjustment of Status: \$3,000 for main applicant and \$1,000 for each dependent</p> <p><b>Note: This fee does not include removal of condition after two years</b></p>
2.	Filing Fees (to the USCIS): Single Applicant
	I-526: \$3675
	I-485 Filing Fee: \$1225
3.	Federal Expenses: \$300-\$400

**Note: The filing fee of \$1225 includes fee for applications I-485, I-765, and I-131, and fingerprinting irrespective of whether I-765 and I-131 applications are submitted along with I-485.**

The fee schedule for EB-5 through Regional Centers (fees are payable by personal or corporate checks) is as follows:

1.	<p>Legal Fees (for our Office):</p> <p>\$7,500 payable as follows for preparing I-526 Immigrant Petition: \$5,000 at the commencement of the case and the rest \$2500, to be paid on the 1st day of the month following the month in which the case is opened by the Law Offices.</p> <p>For preparing I-485 Adjustment of Status: \$3,000 for main applicant and \$1,000 for each dependent.</p> <p><b>Note: This fee does not include removal of condition after two years</b></p>
2.	Filing Fees (to the USCIS): Single Applicant
	I-526: \$1500
	I-485 Filing Fee: \$1070
3.	Federal Expenses: \$300-\$400

**Note: The new filing fee of \$1070 includes fee for applications I-485, I-765, and I-131, and fingerprinting irrespective of whether I-765 and I-131 applications are submitted along with I-485.**
